## AFLSE Scholarship Update

The awards for the coming year's scholarship program have been decided after careful review by the AFLSE Committee. Three full tuition scholarships will be made to American (or permanent U.S. resident) graduate students who will have their first experience at the LSE for the academic year starting this fall. A record number of applications were received this year, a 40% increase over last year. With an eye to both academic excellence and financial need, the committee reviewed 206 files, replete with resumes, transcripts, personal statements, references, and financial information. The next issue of the AFLSE Newsletter (due out in the Fall) will report on the awardees themselves. As always, many thanks to members of the committee and particularly to Jane Plakias, who administers the program, for all their hard work to enable first class students to attend the LSE.

## New Balkan Program at LSE Funded by Soros

The Open Society Institute, founded by LSE alumnus George Soros, is to grant \$1,000,000 to the LSE Foundation to establish a Faculty Development Program for Fellows from the Balkans at the LSE. The program will receive matching funds from the British Foreign and Commonwealth Office. The goal of the program is to improve the research and teaching capacities of Balkan universities. The project will

bring 30 junior and mid-level academic staff to LSE for successive periods of three months, over a three-year period, to participate in a research program and to improve teaching methods and curricula.

## Book Ends

**Jay Winik**, M.Sc. graduate from the LSE, is author of *April 1865: The Month That Saved America*. A telling of the last crucial month of the Civil War, Winik argues that the United States "did not arise naturally ... but was made, almost abstractly, out of ink and paper, crafted by lawyers and statesmen." As of early June, *April 1865* was number 19 on the New York Times Paperback Bestsellers List.

**Coralie Bryant**, 1963 Ph.D., with Marc Lindenberg, has written *Going Global: Transforming Relief and Development NGOs*. The authors explore how organizations are responding to the changes globalization demands, how infrastructures are being organized on a worldwide basis, and the challenges of accountability, evaluation, and organizational learning. John Clark of the Centre for Civil Society at the LSE has called *Going Global* "an essential tool for leaders and staff of NGOs."

**Elizabeth M. Schneider**, 1969 M.Sc. graduate and Rose C. Hoffer Professor of Law at Brooklyn Law School, has just published *Battered Women and Feminist Lawmaking* (Yale, 2000). The book received the 2000 Professional/Scholarly Publishing Award of the Association of American Publishers in Law.

## In Memoriam

**Lord Peter Thomas Bauer**, who served for 23 years as Professor of Economics at the LSE, recently died at the age of 86. Lord Bauer was known most notably for leading the intellectual assault on foreign aid, which he came to stigmatize more precisely as "government-to-government transfers." Prior to his death, Lord Bauer was to have flown to Washington, DC to receive from the free market Cato Institute its inaugural Milton Friedman prize—\$500,000—for advancing liberty. Elevated to the House of Lords by Margaret Thatcher in 1982, he devoted his maiden speech to denouncing the damage and dependency caused by the post-war welfare state in Britain. His contributions to economics and economic theory were immense.

**Eleanor Timberg**, writer, researcher, editor, and activist for the disabled, died at her home in Washington, DC on May 23<sup>rd</sup> at the age of 89. An active attendee of many AFLSE functions in DC, Timberg did graduate work at the LSE and studied under Harold Laski before he became the Labour Party's chair. She was also a 1934 graduate of Smith College. She is survived by her husband of 61 years and four children.

The AFLSE sends its most heartfelt condolences to the families, friends and loved ones of both Lord Bauer and Ms. Timberg.

President's Report - April 2002

**T**he past year has been another very busy one for the AFLSE, with many accomplishments and also continuing challenges.

First, let me mention accomplishments!

- Just over a year ago we learned that our office provider was moving out of the area. By early June, the decisions about new arrangements were made and the transition had been accomplished with amazingly little disruption. We are grateful to Cathy Fink for her good send-off, and for all the work she did from 1998 to 2001 to improve AFLSE's organization. And our new provider, RPL Office Services is certainly carrying on the good work.
- Thanks particularly to our energetic chapters expert, Leslie Griffin, volunteers have been enlisted to revive several chapters. Through her efforts, AFLSE's attention to chapter resources and potentials has surely increased.
- We have also made progress electronically, with ListServers established for five more areas, making available this resource for membership communication in a total of 7 chapters, for ready sharing of meeting information, career advisory information, and other news.
- Our Newsletter editor has valiantly produced three issues, covering many AFLSE and LSE fronts.
- We now have reason to hope that our membership decline has bottomed out – again thanks to the work of the many who have discussed, researched, drafted, and discussed again the many aspects of this foundation of our existence. Challenges have included obtaining information about new alumni and temptations to use easy electronic communications about activities with LSE graduates irrespective of AFLSE membership status.
- Notwithstanding lower investment income from our small endowment, the scholarship program continues at the level of three full tuition awards for graduate study at the LSE, thanks not only to the volunteers dealing with the applications and the devoted work of Jane Plakias, but also to the anonymous donor of a full scholarship for the current year and to the LSE Second Centennial Fund offer to round out available funds for the third scholarship for 2002-03.

Even so, challenges for the coming year abound. Among them are the necessity for increasing membership much more to cover our operating costs – and continuing effort to keep those costs as low as possible. Further refinements to our website may help with this. Developing effective working relations with LSE is another realm full of challenges, ranging from development of efficient transfer of database-related information (and particularly the information about leavers), to small amounts of financial assistance for specific activities, to help with improved publicity about our existence, activities, and resources. More networking for career development advice is also high on our agenda.

As always, the continuing shining positive that propels our many activities is the dedication of many volunteers who keep the organization going – chapter heads, committee members, committee chairs, and other officers. One piece of evidence for increasing involvement is that size of our ListServ for leaders had to be increased, to now include more than 60 people. Many thanks to all for their many contributions.
