Honors for former LSE Director Giddens

Joins House of Lords and made
Honorary Fellow of the School

Professor Anthony Giddens, director of the School from 1997-2003, has been made a life peer.

The announcement was made as the UK government conferred 46 new peerages on Saturday, May 1. Lord Giddens will take his seat on the Labour benches of the House of Lords at the opening of the next Parliament. In the upper House of the British Parliament he will join six former or present academics: Lords Dahrendorf, Desai, Layard, Wallace, Wedderburn, and Lady Blackstone - alongside some 31 other alumni peers.

In January 2004, he was made an honorary fellow of LSE, an award for those who have achieved distinction in the arts, sciences or public life, or who have rendered outstanding services to the School. January 2004. Many would feel that Lord Giddens qualifies on virtually all of these criteria. In addition to his own distinguished academic career, he was an indefatigable Director, raising the academic profile of the School around the world, and attracting an increasing number of outstanding students to an ever-improving campus infrastructure.

One of his last acts as Director was to preside over events, in June 2003, celebrating the success of the Campaign for LSE in raising more than £50 million in philanthropic support.

Since retiring from the School in September 2003, he has been busy with international speaking engagements and writing. His latest book *The Progressive Manifesto* (Polity Press) was published in autumn 2003.

AFLSE President's Report, 2003-4

I am delighted to report that the British Ambassador will be hosting a reception on behalf of the AFLSE on Friday, October 15, and that LSE Director, Sir Howard Davies will be guest of honor. The next day, an AFLSE Board Meeting will be held, plus a series of events to be organized by the Washington, DC Chapter, including a dinner with a distinguished alumnus speaker, and possibly, sightseeing tours, and a soccer match (see *Chapter News*).

The "Alumni Weekend", which has the potential to become an annual event in other US cities, is an innovation to be followed by others during the next few months. This reflects the fact that, after a period of uncertainty, the future of the AFLSE is more settled. It is not the policy of the LSE Office of Development and Alumni Relations (ODAR) to implement the proposals made by Fiona Hodgson, then CEO of the LSE Foundation, in 2002. The two entities would have developed an integrated infrastructure and effectively the AFLSE would have ceased to exist.

In a December meeting in London with Sir Howard Davies, I assured him of the willingness of the AFLSE to collaborate in whatever policy was in the best interests of the School, and of the alumni body in the United States.

In an April meeting at the LSE, I repeated this position to ODAR Director, Mary Blair (see Page 4) and Matthew Horton, Head of Alumni Relations. I was told that policy for the USA did not differ from that for any other country - the AFLSE should continue to be self-supporting and responsible for all alumni activities, with the exception of one or two events per year to be sponsored by ODAR/LSE Foundation.

This means that the AFLSE has no realistic alternative but to continue as a membership-based, dues-paying organization, and I urge all of you, with the exception of life-members, to ensure that you have paid your dues for 2004 (see page 5). Partially paid life members should have received a recent letter encouraging them to continue with their payments.

In return for this support, I am proposing changes to reduce costs and increase alumni participation, some of which are underway. A major proposal is to invest in the AFLSE website to improve its appeal and functions, with a national calendar of events, accessed and updated by chapter leaders, pages for networking and

Passing of Eminent Alumnus

Clark Kerr, President of the University of California system in the 1950s and turbulent 60s, died in December at the age of 92. He was described as having created "the blueprint for public higher education in the United States....He mass produced low-cost quality education and research potential for a nation that hungered for both" *Washington Post* (Dec 2, 2003)

He studied at the LSE in the 1930s and later became an Honorary Fellow.

AFLSE Scholarship Program

The AFLSE has awarded one full-tuition scholarship for the academic year 2004-2005. The recipient, who was selected from nearly 107 applicants, is **Michelle Kim**. Michelle is a 2004 graduate of the University of Pennsylvania, with a major in Economics. At the LSE she will be studying for an M.Sc. in Health, Population and Society, with the goal of working in health policy. She has had several public health internships and is particularly interested in children's health issues.

Our thanks are extended to the Scholarship Committee who reviewed all the applications: **Beth Halpern, (Chair) Sean Culhane, Rob Keast, Sudhir Rajkumar and Karen Schroeder**. Many thanks also to **Jane Plakias** for administering the program, and for sterling service in putting together the application packages at a time when she was facing a major revision of previous hip surgery.

Based on the Investment Committee recommendations, it is likely that only one annual award will be made for the foreseeable future. Plans are now underway to introduce a new application and selection system for this award, in collaboration with the Financial Support Office at the LSE, since financial aid is only available to those determined to have academic merit. An on-line application system for financial aid has been introduced, and it may be possible for those who wish to be considered for the AFLSE award to indicate that they are willing to share their information without contravening data protection laws.

Another change to be introduced for the 2005-6 academic year is that AFLSE awards will not guarantee to cover full tuition costs. Different fees are now charged for different courses, and range from approximately \$20,000 - \$28,000. Future awards will only meet the lowest tuition fees charged.

Mary Blair takes over as head of the LSE Foundation

Dr Mary Blair, Director of ODAR since 2000, has been given overall responsibility for the LSE Foundation. A search is under way for a successor to former CEO Fiona Hodgson. The appointee will report to Mary, with the title: Executive Director.

Mary joined the LSE from the development office at Johns Hopkins University, and is a member of a UK task force on increasing philanthropy for higher education. The LSE hiring of a fund-raiser from across the Atlantic was noted in an article on the poor performance in the development field of British compared with US universities, *Economist* (April 17, 2004)

Alumni/ae in the News....

Paul Volcker

Chair of the Board of Governors of the Federal Reserve System from 1979-87, he has since been an investment banker, and chaired numerous bodies: a panel investigating the handling by Swiss banks of the accounts of Holocaust victims, the International Accounting Standards Committee Foundation, and a distinguished bipartisan Commission on the Public Service. Now in his 77th year, he has accepted a new challenge: an appointment by Kofi Annan, UN Secretary General to investigate alleged corruption in the UN-run oil-for-food program, begun in Iraq in 1996.

A committed and active alumnus of, the LSE, he is also the subject of a new book: *Paul Volcker: The Making of a Financial Legend* by Joseph B Treaster.

Maleeha Lodhi

Dr Maleeha Lodhi received both a B.Sc. (Econ) ('76) and Ph.D. in Politics ('80) from the LSE, and taught Politics and Sociology at the School from 1980-85.

She twice served as Pakistani Ambassador to the United States, from 1994-97 under Benazir Bhutto, and 1999-2002 under General Pervez Musharraf, after he staged a coup against the elected prime minister. During each of her Washington appointments she entertained members of the AFLSE at the Embassy, and eloquently presented a rationale for Pakistani policies under both governments.

Dr Lodhi is now Pakistan's High Commissioner (Ambassador) to the United Kingdom, and was made an Honorary Fellow of the LSE in January.

Princeton University Provost, Amy Gutmann has been nominated to be University of Pennsylvania President. An alumna of Radcliffe, Harvard and the LSE, she is the author of *Identity in Democracy*.

The LSE ranked 5th in the Guardian's 2004 University Guide. Cambridge came first, followed by Oxford, Imperial College, the School of Oriental and African Studies and the LSE - <http://education.guardian.co.uk/>

LSE Director, Sir Howard Davies, former chairman of the Financial Services Authority, has joined the 11-member board of the investment bank Morgan Stanley, as one of only two European directors. *Daily Telegraph* (January 9, 2004)

In 2003, the LSE admitted a higher proportion of UK students from state schools and colleges compared with 4 years earlier, with 64 percent from the state sector and 18 percent from the lowest social classes. This compares with 55 percent of admissions from state schools to Oxford and Cambridge, each of which admitted only 9 percent from the poorest families.

The government had pressured the top universities to admit more students from the state sector and the proportion admitted by the LSE rose 7 percentage points during the 4-year period. *Daily Telegraph* (December 11, 2003)
