## FIVE MEN, THREE WOMEN WIN 1983/84 AFLSE SCHOLARSHIPS

After considering 66 completed applications, the AFLSE Scholarship Committee selected five men and three women to receive awards of \$2,500 each for graduate study in 1983/84. The winners include a medical student, a law clerk, a congressional aide, a public administration consultant--all of whom earned their bachelor's degrees between 1972 and 1982--plus three others who graduated from college last June.

The departments in which these scholars have just begun studying at LSE are Economics, International Relations, Law, Political Theory, and Social Policy and Planning.

The five successful candidates who have been out of school for a time are as follows:

- Elie Canetti of Berkeley, Calif. (M.Sc. in Economics). Mr. Canetti earned a B.S. in Political Economy of Natural Resources, with highest honors, at the University of California, Berkeley, in 1982. He served an internship with the Alaska Center for the Environment.

- Susan J. Hart of Alexandria, Va. (Ph.D. in International Relations). Ms. Hart earned a B.A. and an M.A. in Foreign Affairs at the University of Virginia in 1972 and 1978. She has worked as a financial writer in London and as a consultant at the Institute of Public Administration in Washington, D.C.

- Kerry Kircher of Ann Arbor, Mich. (LL.M.). Mr. Kircher earned a B.A. in History, with distinction, at Stanford in 1976 and a J.D., magna cum laude, at the University of Michigan Law School in 1981. He has been a law clerk at the U.S. District Court, Eastern District of Michigan.

- William A. Levine of Chicago, Ill. (M.Sc. in Social Policy and Planning in Developing Countries, with an option in Health Planning). Mr. Levine, now in his third year at Northwestern Medical School, has obtained a one-year leave of absence to study at LSE. He earned a B.A. in Political Science, magna cum laude, at Princeton in 1979.

- Elizabeth Neuffer of Washington, D.C. (M.A. in Political Theory). Ms. Neuffer earned a B.A. in European History at Cornell in 1979. She has been a reporter, an assistant press secretary to Congressman Bill Green (R-N.Y.) and a legislative aide to Senator Christopher Dodd (D-Conn.).

The three recent graduates who won scholarships are as follows:

- David J. Bederman of Doraville, Ga. (M.Sc. in Sea-Use Law, Economics, and Policy). Mr. Bederman earned a B.A. at Princeton with a major in International Relations and a minor in East Asian (Chinese) Studies.

1982/83 SCHOLAR  
REPORTS ON  
INTERNSHIPS IN  
DIPLOMA COURSE

Bill Erysian, a 1982/83 AFLSE scholar who worked for National Public Radio in Fresno, Calif. before studying at LSE last year, has reported on the success of a new internship program he and others at LSE implemented in 1982/83. Twelve students gained on-the-job experience in volunteer work at organizations that included The Financial Times, American Broadcasting Company, Conservative and Labour parties, South magazine, an international video distributor, and banks.

The internship program was devised two years ago by students and staff in the Diploma in International and Comparative Politics course, but first implemented in 1982/83. Most internships lasted from six to eight weeks and involved between five and fifteen hours per week, as arranged by the students involved.

Bill writes that the program has not yet become an official part of the Diploma course, but the goal is to incorporate it into the LSE calendar, perhaps as a class option. He adds, "The success of the internship program depends to a large degree on the initiative of the Diploma students for each particular year....The most important news, however, is that there appears to be enough interest this term to keep the program going. I think the new Diploma students recognize that they have a good thing going here, not only for themselves but for the future reputation of the Diploma program itself."

## INFORMATION ABOUT AFLSE SCHOLARSHIP PROGRAM

Approximately eight scholarships in the range of \$2,500 each are awarded annually to U.S. citizens or permanent residents of the United States, for one year of graduate study at The London School of Economics. Students who are already enrolled at LSE are not eligible.

Selection of recipients is based on college transcripts, letters of recommendation, a personal statement of reasons for selecting LSE and of the course of study to be pursued, and financial need.

Completed applications must reach AFLSE by March 1 of the year of intended enrollment. Since the required AFLSE documentation largely coincides with that required by the LSE admissions office, applicants may find it convenient to provide duplicates of submissions made to LSE.

Although applicants should not wait for acceptance by LSE before applying for an AFLSE scholarship, they must have applied to LSE for admission in order to be considered for an AFLSE award.

The Scholarship Committee expects to make its selections no later than April 15. An AFLSE award is not final until admission to LSE has been confirmed. Awards are paid directly to LSE to be credited to each student's tuition account. The AFLSE is not able to provide student loans or to give an award for partial attendance during an academic year.
