Iraq takes its toll of LSE alumna

Distinguished Journalist and
AFLSE Scholarship Recipient

Elizabeth Neuffer was United Nations bureau chief for the *Boston Globe*, and one of its foreign affairs correspondents. She went to Iraq at the end of April, after the worst of the hostilities had ended, but was killed in a car crash on May 9, together with her translator.

It is tragically ironic that she should meet her death in this way, since she had received numerous awards for reporting from the center of some of the worst conflicts of the past decade. In 1997 she received the Novartis Prize for Excellence in International Journalism, from the Johns Hopkins School of Advanced International Studies, for reporting on war crimes in Bosnia and Rwanda. In 1999 she was awarded the Courage in Journalism Award from the International Women's Media Foundation, and later received an Edward R. Murrow Fellowship from the Council on Foreign Relations. She used the fellowship to produce *The Key to My Neighbor's House: Seeking Justice in Bosnia and Rwanda*, published in 2001.

Elizabeth was born in the Boston area in 1956, did her undergraduate work at Cornell, and was awarded an AFLSE scholarship in 1983 to do graduate work at the LSE. She spoke of her time at the School as a "wonderful experience", and credited her study of political philosophy with making her "think critically for the first time".

Former US Ambassador to the UN, Richard Holbrooke, described Elizabeth as "one of the best". —*Boston Globe*, (May 10, 2003)

New AFLSE President Closer links with LSE Foundation planned

Patricia Stockton ('75, '96) was elected President of the AFLSE at the April 5 Board Meeting, taking over the reins from Ann Imlah Schneider. Patricia writes:

The AFLSE was founded in 1970 to foster and sustain relations between the School and its alumni in the United States. To this end, it established chapters around the country, raised funds for the LSE library, disseminated information to potential applicants, and developed a scholarship program for graduate study. These activities were all initiated and largely undertaken by volunteers.

In 1999, the School itself established the LSE Foundation in New York, with a professional team, led by Fiona Hodgson ('79). During the past year there have been negotiations between Fiona and the AFLSE (see President's Report-April 2003) with the objective of establishing a closer relationship. It is hoped that the Foundation will be able to provide administrative support for the AFLSE - which is now paid for by membership dues (see page 5). This would enable us to concentrate on supporting chapter activities.

LSE Foundation hosts Washington seminar

Major attraction for East Coast
Alums

Developing Futures was the title of an all-day seminar, sponsored by the LSE Foundation at the Cosmos Club, in Washington, DC on March 5. Introduced by LSE Director, Tony Giddens, moderated by former Federal Reserve Chairman, Paul Volcker ('52), with panels including George Soros ('51), and other distinguished representatives (primarily alums) from the worlds of business, the media, policy-making and academia, the seminar was an outstanding success.

Originally planned for 200, the response to the invitations was so overwhelming that space was created for 350. Later acceptees were included in the seminar by audio-visual hook-up, but all were accommodated for lunch, at which Paul Volcker was also the speaker. With panels on issues of corporate governance and responsibility, the future of markets, human rights, and equitable economic development, many wished that there were twice as many hours in a day.

Death of D.P. Moynihan Scholar, Senator, Ambassador and former AFLSE President

Tributes to the life and accomplishments of Daniel Patrick Moynihan were published around the world, following his death in March. Many noted his enjoyment of the time he spent as a Fulbright Scholar at the School ('50-'53). He is mourned by the AFLSE of which he served as President in the late '70s.

News in brief.....

George Soros ('52) stated that he opposes the U.S. bid at the United Nations to win control of Iraq's oil. He therefore plans to form a group to monitor the Bush administration's use of oil-sales revenues, to ensure that they are used for Iraq's recovery from the war.
Washington Post, May 21

Ravinder Singh Bhalla, a Newark lawyer, described as having studied at the LSE,

asserted his rights on behalf of the Sikh community in the United States, not to remove his turban before being admitted to visit a client at the Brooklyn Metropolitan Detention Center. He was pictured in the *New York Times*, January 27, having won a ruling from the Bureau of Prisons that a 3ft x 15ft turban is not a hat.

Keith Richburg ('84), an award-winning journalist, is Paris Bureau Chief for the

Washington Post. As an independent, not "embedded" reporter he was on the front lines with the British forces in Southern Iraq throughout the conflict. An African-American, exposed to civil strife in Somalia, Liberia and Rwanda in the 1990s, after which he wrote *Out of America: A Black Man Confronts Africa*, Keith came safely through the hostilities in Iraq, and then flew to Morocco to cover the terrorist bombings in Casablanca, *Washington Post*, May 19.

President's Report - April 2003

The final year of my AFLSE presidency was one in which "expect the unexpected" seemed to be the norm, with challenges to our efforts to maintain an organization for US alumni of the LSE. Most importantly, we should be pleased with our many accomplishments:

- Thanks to a variety of efforts, by many people, our membership numbers topped 1,400 by the end of 2002.
- An updated membership directory was published, to help classmates keep in touch, to assist chapter organizers, to aid prospective students in finding mentors, and to help with networking. Thanks to Sean Culhane, advertising helped to keep the cost down.
- Chapter activities were revived in several parts of the country – and chapters in larger metropolitan area have organized social events, lectures, receptions for LSE visitors, and related activities. Chapter heads and coordinators Leslie Griffin and now Jill Barshay have contributed greatly to these activities.
- We've made progress in the use of ListServers and other electronic communications.
- With the help of a contribution from the LSE Centennial Fund, we were again able to make three full-tuition scholarship awards to deserving and very well-qualified graduate students attending the LSE.
- John Casey, New York chapter leader, was appointed to a committee set up by the Office of Development and Alumni Relations, in London and ably represented the USA in recent discussions on the establishment of a world-wide LSE Alumni Association.
- Two Newsletters were produced in hard copy, and editions in electronic format are being explored.
- At his initiative, our office provider negotiated a new contract, specifying a reduced and fixed number of monthly hours, enabling us to complete the year without running out of resources.

An important potential change for the AFLSE occurred in early April, when Fiona Hodgson, CEO of the LSE Foundation in New York, made a tentative offer to provide a measure of office services for AFLSE's administration. By early September, after meetings of the AFLSE Executive Committee and an *ad hoc* advisory group of former presidents, an agreement was signed between the AFLSE and Fiona, to serve as the basis for more detailed discussions. This was approved at the November 2 meeting of our Board and at the November 18 meeting of the LSE Centennial Fund Board. In December, Fiona Hodgson obtained an approval from LSE's administration for a new "external relations" position in the LSE Foundation Office. An appointment to this position has yet to be made, and details of any transfer of administration by the AFLSE have yet to be worked out. A major potential change is the elimination of membership dues in order to foster an all-inclusive alumni body.

In the meantime, we need dues income to cover the usual current expenses. So what will our strategy be for finding income to cover the chapter expenses for activities that can get alumni more involved, if dues are abolished? Our Newsletter may be folded into the Foundation's semiannual reports on fundraising. How will we foster a lively exchange of news about American alumni? Database management will also require continued attention. In the discussions about future administrative arrangements it was agreed that the AFLSE would maintain its scholarship program, for many years ably administered by Jane Plakias. However, the administrative costs for the scholarship program are increasingly dependent on annual grants from the LSE, presenting another challenge.

In closing, I want to express many, many thanks to all who have contributed so much to the running of the AFLSE these past four years – officers, chapter heads, Board members, committee chairs, former presidents, and all other volunteers – and, of course, Jane Plakias for her devotion to the scholarship program and Cathy Fink, previous administrator, for her organizational talents and perspectives. All have been wonderfully responsive to requests for help, and the organization could not have survived without you.
